GARLAND NINE IMPRISONED FOR ACTING AGAINST BABY-SLAUGHTER

During the week of May 14-17, 2024, the pro-life activists known as the Garland 9 received their prison sentences. To reiterate some history, they conducted an “old-style” rescue at Cesare Santangelo’s abortuary (Washington Surgi-Center) in Washington DC. The rescue occurred on October 22, 2020. This is the same abortion mill that killed the babies that Lauren Handy (one of the Garland 9) and Terrisa Bukovinac obtained from a pick-up driver on March 25, 2022.

Several of the activists were tried on August 9, 2023; the remainder were tried on September 6, 2023. They were all found guilty. Because the pro-abortion judge declared these rescuers (including three grandmothers) to be dangerous, they were imprisoned until their sentencing. That is to say they were jailed before they were sentenced. Paulette Harlow, owing to health issues, was placed under house arrest instead. But now the sentencing has occurred for most of them.

The sentence lengths vary amongst them. They are listed below:

Lauren Handy – 57 months
 John Hinshaw – 21 months
 Will Goodman – 27 more months
 Joan Andrews Bell – 27 months
 Jean Marshall – 24 months
 Herb Geraghty – 27 months
 Jonathan Darnell – 34 months
 Paulette Harlow – 24 months

The Thomas More Society is planning appeals of these sentences.

The nine months during which they were incarcerated will be credited to their sentence length.

Heather Idoni has not yet been sentenced; her sentencing will happen in a few weeks. Moreover, she faces trial on July 30 for another unrelated rescue. Her sentences from these rescues could amount to 30 years or more.

During their pre-sentencing incarceration, two of the older women suffered medical abuse.

Heather Idoni, age 59, had a stroke about May 1. She had three stents for arteries above her heart. She is accusing the DC jail of gross medical neglect for withholding medication related to this condition. The jail is administering some but not the blood thinner.

She is also diabetic. She was told that medication for that was “not available”, although it was available at other jails. Her blood sugar numbers are one hundred points higher than they should be.

In April, she was put in solitary confinement for 22 days as punishment for sharing food with another prisoner. During that time, the lights in her cell were on constantly, allowing her little to no sleep. The temperatures in her cell were kept at about 40 degrees, with her only having one sheet and one blanket. Bear in mind that she is a medically fragile woman.

Jean Marshall, held in Alexandria Detention Center, also reported freezing conditions in her cell. She contracted pneumonia, but was not treated for three weeks. Moreover, being diagnosed with osteoarthritis in both hips, she was scheduled for hip surgery on October 23, 2023. The prison did not allow her to keep

that surgery appointment.

The US House Pro-Life Caucus Co-Chairmen, Chris Smith (R-NJ) and Andy Harris (R-MD) are demanding answers regarding Idoni's and Marshall's situations from the U.S. Marshall Service and the Bureau of Prisons. When they wrote that letter, they gave the directors of these agencies until Friday to respond. Friday, May 17, is the date of the writing of this article.

The Thomas More Society is planning appeals of these sentences. No matter what one might think of the advisability of clinic rescues – and opinions vary amongst dedicat-

Working to Defeat the Reproductive Freedom Amendment

On Tuesday, April 30th, Deborah Brocato, director of Health Not Harm, gave a presentation on the so-called “Reproductive Freedom Amendment” that will be on the ballot in November. The presentation began at 6:00PM and occurred at St. Elizabeth’s in Rockville MD. Between 35 - 45 people attended.

Ms. Brocato went into great detail concerning the wording and structure of this amendment, illustrating how this is a gigantic trampling of parental rights that goes beyond the promotion of abortion. Please observe the wording in bold. Notice how the words “persons” and “individuals” are used – not words like “woman” that would make clear that the amendment would apply only to adult women. Also, the amendment states that its scope encompasses not only abor-

“That **every person**, as a central component of an **individual’s right** to liberty and equality, has the fundamental right to reproductive freedom, **including but not limited to** the ability to make and effectuate decisions to prevent, continue, or end one’s own pregnancy. The State may not, directly or indirectly, deny, burden, or abridge the right unless justified by a compelling state interest achieved by the least restrictive means.”

tion, but everything else that is commonly considered “reproductive freedom”, such as “gender-assignment” surgery, puberty blockers, etc. Efforts were made to clarify the amendment language to exclude minors and to make the ballot lan-

guage match the amendment. Pro-abortion legislators quashed those measures.

An immediate course of action for which Brocato sought volunteers is to be at the polls on May 14, Maryland’s primary election day and to be at the polls during early voting. The aim is to give to voters, as they depart from the polls, information regarding this amendment. By the time that this article is distributed in the Defend Life newsletter, the primary election will have

already occurred. However, there will be many more venues at which to educate the voters, such as various civic events. Three holidays during which there are parades and other celebrations are Memorial Day, Independence Day and Labor Day. Additionally, there are various fairs and outdoor festivals that traditionally see much in the way of political and civic activism.

Of course, there are churches in which educational events can occur. Because the effort to stop this amendment does not entail partisan politics, churches and other houses of worship are entirely free to engage in the effort to stop this amendment without fear of jeopardizing their 501c3 status. Even if that were not the case, Christian churches have a moral imperative to urge their congregations not only to vote against the amendment, but also to campaign for its defeat.

Sadly, though, I have seen firsthand at least one Catholic church drag its feet when it comes to supporting the efforts of Health Not Harm. I tried to get my own parish to advertise in its bulletin this April 30th event. When I asked why the notice did not appear in its bulletin, I was told in an email by parish personnel, “our desire is to focus on the resources provided by the Maryland Catholic Conference. I am sorry, but we will not be promoting the St. Elizabeth’s event that is coming up.” Not understanding why she thought that the efforts of Maryland

Blessed Are Those Who Mourn: A Call to Action for Victims of Abortion

Webster's Dictionary defines "Crimes Against Humanity" as a deliberate act, typically which is a part of a systematic campaign that causes human suffering or death on a large scale. The campaign of Abortion in America, over the past 50 years, is the epitome of such crimes. The inhumane slaughter of 64,000,000 defenseless children and the exploitation of their naive mothers have caused immeasurable suffering to both abortion victims and those of us who have been forced to witness the systematic deterioration of the conscience of our nation.

BOB NEWMAN • Irreplaceable • One of a Kind

Bob Newman, a great hero of the Pro-Life movement, went to his Eternal Reward Tuesday, April 2. He died at home surrounded by his huge family in one of the Pittsburgh suburbs. Bob who was a native New Yorker had grown up on Long Island. He met his wonderful wife, Joanie, while both were in kindergarten. He was an ardent Brooklyn Dodgers fan. As a young child in a Catholic parochial school, he wrote a brilliant rhyming poem about Dodger great Cookie Lavagetto. The nun

was not pleased.

Bob, always a gutsy New Yorker, relocated to the Pittsburgh area where he lived the bulk of his adult life. He and Joanie were the proud parents of 10 adult children and many grandchildren and even some great grandchildren.

I first got to know Bob shortly after we did our first Truth Tour in the year 2001. Our next to last STOP was to be in Rehoboth Beach, Delaware. But to get to Rehoboth, we had to travel the Coastal Highway. It was a busy Saturday summer morning and traffic was jammed on this four-

lane highway which I later found out that was ***par for the course***. **There was no way we were going to get to Rehoboth in time for our Noon STOP so we improvised.** We simply parked our caravan on the shoulders, got out our signs and set them up on both sides of the median strip. Soon we were joined by the

Delaware State Police who told us ***we had to leave***. Not wanting to jeopardize our afternoon on the Boardwalk in Ocean City, we complied. But here's the good that resulted. One of Bob's close friends from Pittsburgh was vacationing there. She spotted our Truth Tour signs as we were being ***chewed out*** by the **Delaware State Police**. She passed the idea onto Bob who loved it and ran with it.



Soon Bob was doing dozens of Face the Truth Tours all over Pittsburgh, all over its numerous suburbs, and all over Pennsylvania including cities like Greensburg, Altoona, Johnstown, Harrisburg, York, Lancaster and Reading as well as Morgantown, West Virginia.

Here is one great story. A gutsy lady stopped her car coming out of Pittsburgh's heavily trafficked Liberty Tunnel during rush hour. In spite of ***deafening honking***, she rushed over to tell Bob that **she now had a granddaughter because of his great work**. Archdiocese of Baltimore Social Ministry Convocation — How to Justify Gay Perversions on the Sly

We resume with coverage of the Archdiocese of Baltimore's Social Ministry gab-fest. After the panel discussion, the morning workshops commenced. I attended the one conducted by Father Bruening, entitled "Like Every Disciple: Putting It Into Action". It focused on Archbishop Lori's document of the same name that dealt with LGBT people in the Church.

Bruening stated that this document gave a blueprint for LGBT parish ministries. Then he stated that his parish (St Matthew's) already had a history of such ministry. Well, if one calls dragging the name of St Matthew's through the filth of gay pride parades and lending credibility to all sorts of perverse sexuality a "ministry", we can see his point. In reality, it is committing all sorts of blasphemies and sacrilege. He thinks Lori was sharing his dreams in this document. I fear he may be correct and that dream in reality will result in nightmares as these "ministries" grease the skids to hell for so many souls embroiled in sexual vices.

He then stated that the Church exists to make disciples of Jesus Christ. We call that a half-truth. In fact, the Church's overarching mission is to save souls, i.e. snatch them from hell and help them achieve heaven. See how they deftly excise any mention of life after death? After we die, we ultimately go to heaven or hell. That truth, too, is removed from consideration. Bruening spoke of the "life-giving tension of charity and truth". Why is there this attempt to pretend that there is "tension" between charity and truth? One does not exist without the other. In 1 John 4:8, we read that "God is love". In John 14:6, Jesus says "I am the way, the truth and the life". Ladies and gentlemen, God has no "tension" in Himself and it would be blasphemous to allude otherwise.

Then he spoke of "forming relationships" and a subsequent "earning the right to speak". What gives Christians the "right to speak" has nothing to do with "relationship". Rather, that "right to speak" is actually a command from Jesus to promulgate His truth. Later he said of ministry in general is that the greatest thing is to lead someone to a deep, intimate love of Jesus Christ. Again, that doesn't happen without

repentance. In this entire tome, the word "repentance" isn't mentioned once.

After some more remarks by Bruening, the panel discussion began. First we heard from Samuel who is involved with the LEAD gay-enabling group. Let's take a few minutes to examine just what LEAD advocates. At the bottom of this page <https://www.leadlgbtministry.com/gallery> we see them advertising an "Interfaith Renaming Ceremony". People pretending to be of the opposite sex often change their names to conform to their fantasies. Clicking through the pictures in the gallery, one sees pictures of St Matthew's parishioners participating in Baltimore's gay pride parade. If one clicks all the way through the gallery, they are taken to this video that gives a tear-jerker account of two lesbians get-

ting civilly married. The two sing the praises of Father Muth who, at the 3:59 mark, seems to be joining them at their “reception” dinner. Aside from the abysmal mockery of marriage, this video makes plain that indeed LEAD and the other “gay ministries” seek to undermine the Church’s teachings on marriage and sexuality. Let us now resume with this workshop. Father Muth was at this workshop, by the way.

We then heard from Diane Lesko, who heads Open Arms Ministry, based at the Church of the Resurrection in Ellicott City. Here is their website <https://www.resurrectionmd.org/openarms>. First go all the way to the bottom and notice that the copyright for this site is held by Church of the Resurrection itself. This site advertises Fr. James Martin’s pro-sodomy propaganda as well as PFLAG. It features a list of “welcoming parishes”. That’s thinly-disguised code-talk for perversion-enabling parishes. Ladies and gentlemen, *all* healthy parishes are welcoming of the *repentant* sinner. In addition to the word “repentance” mentioned above, the word “confession” is likewise not mentioned. Frankly, I didn’t catch much of what she or Samuel had to say; they both held the microphones so close to their mouths that their voices were muddled.

Lastly we heard from Gordon Creamer. He runs the “Embracing God’s Gifts” thing at St. Ignatius in Baltimore. One little tidbit that he didn’t mention in his introductory remarks that he is gay-married. We discovered that about five years ago. Look at the two pictures in this article. In the top one, Creamer certainly is dressed normally enough. The other one? That’s obviously a different story. He’s the one in the frilly yellow hat and spaghetti-

strapped-dress? His hand is on the shoulder of his “husband” Brian Fitzek. That picture was found on Fitzek’s facebook page several years ago. Please refer to the Nov-Dec 2019 issue of the Defend Life newsletter for action taken upon this discovery.

Creamer seemed to home in on this idea of “accompaniment”, stating that his pastor at the time was influential in that focus. I wonder if that was the same pastor that I called to inquire as to the appropriateness of a gay-married guy being allowed to wield positions of influence at the Church. Anyway, he spoke of “accompanying the parish, to help them understand what it is to be an LGBTQ+ person”. I wonder when we’ll hear what it is to be a mass-murdering person. If the latter sounds ridiculous, so does the former.

After Creamer finished, Fr Bruening enthused, “every time I hear Gordon Creamer speak, my heart melts!” Unless he is completely clueless as to Creamer’s “marital status”, I can only surmise that this adulation signifies approval of the same.

He answered a question regarding Courage and Encourage. They are obedient to the Church and don’t appear to be utilizing any subterfuge in promoting perverted ideas

and practices. I regret that nothing further was said of them, and they did not have a table open during the lunchtime session.

“savory flavor ingredients” with HEK 293 (harvested Human Embryonic Kidneys) for decades. Big Pharma and covert university researchers have been exposed for mass producing humanized mice. tor of Catholic Climate Covenant

I will give some background on some of these people and/or their organizations, not in order of their appearance in the line-up.

We'll start with Ms. Briscoe's organization. Bridge Inc, as evidenced from their website <https://www.bridgemd.org/>, is a community-organizing bunch affiliated with Gamaliel Inc. It is with Gamaliel that a young Barack Obama got started in "community organizing". Gamaliel has quite a few ties to CCHD. To whom did all us convocation attendees have to fork over \$25 to attend this little gab-fest?

Let's look at Catholic Climate Covenant, shall we? Exposes on them and other such organizations have shown them to be into the promotion of population control, one-world government, and earth-worship.
